### PRE-TENANCY FEES (ALL SERVICE LEVELS)

Arranging and facilitating statutory compliance (this is in addition to the costs of the item itself) if not provided on instruction or undertaken by the landlord:

- Energy Performance Certificate (EPC) £50.00 (inc. VAT) or £55.00 outside a N19/ N7/ N6 postcode, per property per tenancy (Plus an additional £30.00 admin fee for non-managed making total fee £75.00 inc. VAT)
- Gas Safety Certificate (GSR) £72.00 (inc. VAT) per tenancy (Plus an admin fee of £30.00 for Non -Managed properties, making total fee £102.00 in VAT).
- Electrical Installation Condition Report (EICR) £150.00 - £426.00 (inc. VAT) per tenancy (Additional £50.00 admin fee for non-managed properties)
- Portable Appliance Testing (PAT) £200.00 (inc. VAT) per tenancy
- Legionella Risk Assessment £96.00 (inc. VAT) per tenancy
- Installing Smoke alarms and Carbon Monoxide £60.00 (inc. VAT) per tenancy
- Testing Smoke alarms and Carbon Monoxide detectors on the first day of the tenancy £50.00 (inc. VAT) per tenancy
- Visual check in compliance with the Homes Act 2018 on the first day of the tenancy £50.00 (inc. VAT) per tenancy

### START OF TENANCY FEES

Set-up Fees: £156.00 (inc. VAT) per tenancy. Referencing for up to two tenants (ID checks, Right-to-Rent check, financial credit checks, obtaining references from current or previous employers / landlords and any other relevant information to assess affordability) as well as contract negotiation (amending and agreeing terms) and arranging the signing of the tenancy agreement.

Additional Tenant Referencing Fees: £48.00 (inc. VAT) per tenant. As Set-up Fees above for additional tenants.

Guarantor Fees: £48.00 (inc. VAT) per guarantor. Covering credit referencing and preparing a Deed of Guarantee (or as part of the Tenancy Agreement).

Deposit Registration Fees (where collected): £60.00 (inc. VAT) per tenancy. Register landlord and tenant details and protect the security deposit with a Government-authorised Scheme. Provide the tenant(s) with the Deposit Certificate and Prescribed Information within 30 days of the tenancy start date.

Inventory Fees: Dependant on the number of bedrooms and/or size of the property; 1 bed - £120.00, 2 bed - £132.00, 3 bed - £144.00, 4 bed - £198.00, 5 bed - £258.00. This is to be carried out by a third party independent inventory company.

Accompanied Check-in Fees: £18.00 (inc. VAT) per tenancy. Attending the property to welcome the tenant(s), confirm the Inventory and Schedule of Condition, explain the operation of appliances, highlight the location of utility meters, stop-cocks etc. and test that all smoke alarms and carbon monoxide detectors are present and in working order. This is subject to an approved Inventory as above.

Landlord Withdrawal Fees (before move-in): £200.00 (inc. VAT) per tenancy. To cover the costs associated with the marketing, advertising and tenancy set-up should the landlord withdraw from the tenancy before it has started.

### DURING TENANCY FEES

**Additional Property Visits: £25.00 (inc. VAT) per visit.**  
Should the landlord request property visits in addition to those within their existing Terms of Business, this covers the costs of attending the property.

**Renewal Fees: £ charged on a sliding scale: Year 1 - 8.4%, Year 2 - 7.2%, Year 3 - 6% and for the rest of the remaining term, (inc. VAT) per tenancy. (Rent per month x % x 12M = charged 6 monthly).** Review rent in accordance with current prevailing market conditions and advise the landlord. Contract negotiation, amending and updating terms and arranging for the signing of a further tenancy agreement. Serve a section 13 Notice if the tenancy is on a periodic basis.

**Right-to-Rent Follow-Up Check: £50.00 (inc. VAT) per check.** Undertaking a repeat check in person on a time-limited visa in accordance with the Immigration Acts 2014 and 2016. Notifying the Home Office should an illegal overstayer be identified. This does not apply to a Tenant-Find service.

**Landlord Withdrawal Fees (during tenancy): £100.00 (inc. VAT) per tenancy.** To cover the costs associated with advising the tenant on the change and the position of the security deposit, transferring the security deposit to the landlord or new agent, notifying all utility providers and local authority (where necessary) and returning all relevant documents held by the agent to the landlord. This does not apply to a Tenant-Find service.

**Arrangement Fees for works over £3000: 5% of net cost (inc. VAT).** Arranging access and assessing the costs with any contractors, ensuring work has been carried out in accordance with the Specification of Works and retaining any resulting warranty or guarantee. Fully managed service only.

### END OF TENANCY FEES

**Check-out Fees: Dependant on the number of bedrooms/ size of the property: 1 bed- £120.00, 2 bed: £132.00, 3 Bed - £144.00, 5 bed - £258.00, (inc. VAT) per tenancy.** Third party inventory company to attend the property to undertake an updated Schedule of Condition based on the original inventory.

**Tenancy Dispute Fee: £25.00 (inc. VAT) per hour, per tenancy.** The costs associated with the preparation of all evidence and submitting the case to the tenancy deposit scheme as well as dealing with all correspondence relating to the dispute. This only applies where the agent has protected the deposit.

**Fees for the service of Legal Notices (Section 8 or Section 21): £50.00 (inc. VAT) per Notice ( or free if you have our fully managed service).**

**Deposit Transfer Fees: £60.00 (inc. VAT) per deposit.** Should the landlord request any changed to a protected deposit during a tenancy, this covers the cost associated with legal compliance for said request.

**Vacant Property Management Fees: £15.00 (inc. VAT) per visit.** To cover the costs associated with visiting the property to undertake visual checks outside and inside at a frequency mutually agreed with the landlord.

**Additional HMRC Reporting Fees (inc. VAT) per request.** Responding to any specific queries relating to either the quarterly or annual return from either the landlord or HMRC.
